Section 2, page 2, after line 23, insert –

- ‘() Guidance issued by the Welsh Ministers under subsection (6) must include –
- (a) how a local authority should have regard to the age, disability or other characteristic of walkers and cyclists who are likely to use a particular route, and
 - (b) how a local authority should provide for a particular route to be suitable for safe use by walkers and cyclists at the same time, having regard to the numbers of each who are likely to use that route.’.

- (b) reporting on the funding for active travel made available by the Welsh Ministers, and
- (c) any other information that they consider relevant.’.

- ‘() Any directions or guidance given under this Act by the Welsh Ministers must be reviewed by them within two years of being given and they must publish the results of that review.’.
