Memorandwm Cydsyniad Deddfwriaethol: Y Bil Dadreoleiddio Legislative Consent Memorandum: Deregulation Bill

[15] **Simon Thomas:** Rydym wedi edrych ar y Bil hwn o'r blaen. Mae'r Cadeirydd eisoes wedi anfon llythyr at y pwyllgor yn Nhŷ'r Cyffredin, os cofiaf yn iawn. Mae'r Bil yn awr yn mynd drwy San Steffan, a bydd yn rhaid i ni fel pwyllgor osod adroddiad er mwyn i'r peth gael ei drafod mewn Cyfarfod Llawn, a gwneud penderfyniad ar yr adroddiad hwnnw toc ar ôl inni ddod yn ôl ar ôl y Pasg. Efallai y gallwn drafod hynny yn nes ymlaen, ond mae cyfle gennym i edrych ar y memorandwm yn awr. Credaf fod gan Gwyn wybodaeth i'w hychwanegu at yr hyn

regulations on student loans have been presented in English only because the House of Commons does not operate through the medium of Welsh, essentially. This committee has decided to look at this from the point of view of legislating bilingually in the future. However, at least we have received a different excuse this time for failing to present them bilingually.

Mr Griffiths: There is greater justification this time because this is not a matter of the Secretary of State making regulations for England, and Welsh Ministers making similar regulations for Wales, but that some of the regulations made by the Secretary of State also apply to Wales because of the way in which the powers are devolved. Therefore, there is greater justification on this occasion.

Simon Thomas: Therefore, the part that relates to Wales is a small part of something much bigger. Is that correct?

Mr Griffiths: Yes, it is. He does the same as Welsh Ministers, but also has different provisions for England and Wales.

Simon Thomas: Thank you very much. We will note that, therefore.

Welcome, Eluned.

Simon Thomas: We have looked at this Bill previously. The Chair has already sent a letter to the committee in the House of Commons, if I remember correctly. The Bill is now going through Westminster and, as a committee, we will have to table a report in order for this to be discussed in Plenary, and a decision will have to be made on that report as soon as possible when we return after Easter recess. Perhaps we could discuss that later on, but we have an opportunity to look at the memorandum now. I believe that Gwyn has some information to add to what you

Mr Griffiths: There is not much to add to what is in this paper. Clearly, the Government needs to consider bringing forward a further memorandum. Perhaps the most appropriate thing would be for the committee to write to the Government seeking greater clarity on a few issues. In terms of the issues set out here, I do not see that there is any significant problem with them. However, I think that we need a further memorandum, particularly if you look at the penultimate paragraph, which relates to changes made at committee stage. That partly relates to agricultural holdings that I would expect to be within the legislative competence of the Assembly. Therefore, a memorandum will be required on that issue. There are also more general issues on which we need greater clarity.

Simon Thomas: Thank you very much. Are there any comments or questions? Are you content to accept the report as it stands? I see that you are. So, we will return to the memorandum itself after the Easter recess. Thank you for that.

Simon Thomas: I move that
